

DB's Cart Rental Agreement

Terms and Conditions

- 1. The golf cart shall be returned to the agreed pick up location upon completion of the rental period in as good condition as received, normal wear and tear accepted. The golf cart shall be operated in a safe and responsible manner to preserve and protect the golf cart, lessee's person or property, and the person or property of others from loss of damage. Lessee shall be responsible for protecting the golf cart from vandalism or theft and shall be liable for up to the replacement cost of the golf cart. Lessee agrees to be legally and financially liable for all costs or repairs to the golf cart and for the loss, damage and/or injuries to the person or property and the persons or property of others regardless of fault.
- 2. Lessee shall hold harmless, defend and indemnify Lessor, their agents, employees and affiliates from any and all damages and claims of any nature whatsoever that may arise from the use of said golf cart during the rental period or any extension thereof. Such damages and claims shall include, but not be limited to, damages to the golf cart itself, lessee's person or property, other persons or property, and reasonable attorney fees and expenses which are a result of the lessee's possessions, rental or use of the golf cart.
- 3. The lessee agrees that only persons who are **18 years or older** and possess a valid driver's license as required by law, shall be permitted to drive the golf cart. Lessee agrees to become familiar with the operation and use of the golf cart, to read the GOLF CART INFORMATION section, and to read and comply with any other instructions provided for the operation and use of the vehicle. Lessee agrees to contact Lessor immediately regarding any questions or concerns about operating the golf cart or if there has been any damages caused to the vehicle.
- 4. Lessor has the right to terminate this agreement without notice for any violation of these terms and conditions. If the event of termination, lessee shall not be entitled to a return of the security deposit or any rental fees.

Golf Cart Information

• It is our goal to provide customers with reliable golf carts which have been serviced by our mechanics and optimized to ensure you get the most use from the cart. Do not for any reason attempt to perform maintenance or repairs on the golf cart. In the event a problem arises, please make sure that you are following all the operating instruction and call us at 775-887-2381 immediately. We will assess the problem and if it cannot be resolved over the phone, we will send a mechanic or replace the cart as soon as possible. If the problem results in a loss of use

during the rental period, you will be refunded appropriately. Failure to notify us of a problem immediately will result in loss of use without refund.

- If you are renting an electric golf cart, you will be provided a charger which requires normal 110v service with a recommended 20-amp circuit. It is your responsibility to ensure that receptables with adequate power are available to charge your cart. The charge plugs fits into the cart at the driver's side of the cart and will only fit one way. The charger is "automatic" and will shut off when the golf cart is fully charged.
- Lessee is responsible for normal maintenance during the term of the rental which includes charging the vehicle and making sure tires are inflated properly. Battery water levels must be checking every other week and filled appropriately. If you are renting a gas-powered vehicle, only clean unleaded gas must be used.
- The golf cart key must be removed from the car anytime it is left unattended. A \$25.00 fee will be charged against your deposit for lost keys.
- At no time should there be more than 2 passengers on the cart per seat.
- We inspect our golf carts for damage upon delivery and pick up. You should inspect the vehicle and report immediately any damage, otherwise, any repair cost will be charged against your deposit.
- Any labels or tape must be removed from the cart prior to return or a cleaning fee of \$25.00 per cart will be assessed. If anything needs to be attached to the cart it is advised to use a low adhesive tape.

Insurance

Lessee agrees to provide Lessor a Certificate of Insurance of at \$1,000,000 general liability coverage (property damage & bodily injury) listing DB's Cart Rental LLC, as additional insured. Additionally, the extension of Additional Insured status shall require a Waiver of Subrogation and Primary Wording.

DB's Cart Rental LLC does not offer insurance coverage, so the first step will be to contact your insurance broker and secure the above requirements. If you are unable to secure liability insurance coverage, unfortunately we will not be able to provide the rental.

Golf carts rental reservations are officially booked and confirmed only after rental agreement is signed, dated, and returned and liability insurance has been secured.
